

World Congress on ADHD 25 – 28 April 2019 Lisbon General Conditions for Groups

Congress Fees

The congress organiser is not in a position to grant discounts for groups.

The early bird registration fees are only applicable with corresponding payment by 22 February 2019. Otherwise we have to register your delegates as full paying participants.

Cancellation of Congress Participation

Notice of cancellation can only be accepted if submitted in writing to the Congress Office CPO HANSER SERVICE. In case of cancellation by 22 February 2019 the payment will be refunded, minus a handling charge of EUR 100. No refund can be granted after 22 February 2019.

Name List and Name Changes

The name list should be submitted about 4 weeks prior to the congress.

Name changes submitted less than 14 days prior to the congress will be charged at EUR 25,00 each. Prior to this date, name changes will be accepted.

Group registration will close approx. 4 weeks prior to the congress.

Group Pick Up

Two weeks prior to the congress, CPO HANSER SERVICE will provide the person in charge with the detailed information for the group pick up. If you are not available at the mentioned time, please let us know. In that case, please have your participants pick up their material themselves during the opening hours of the registration counter.

The congress material also includes congress bags. Please be prepared to carry this heavy material.

Loss of Name Badge

The person in charge who will pick up the material has to assure that he/she will forward the congress badges as well as the material to the delegates of his/her group.

CPO HANSER SERVICE is not responsible for missing or lost material and badges.

EUR 50 must be paid to acquire a new name badge in the event that the name badge, which at the same time entitles the holder to attend the congress, is lost.

Changes to the Congress program

In the event of cancellations by speakers or other changes in the main congress program, no full or partial refund of the registration fee can be made.

Liability
